#### **HEALTH GUARANTEE**

We guarantee in writing that your new puppy is free from genetic defects for a period of 12 months. If your puppy were to develop any problems caused by genetics we will replace that puppy with one of like sex, and color at the first available breeding. No money will be refunded. Any claim of a defect must be accompanied with written proof from a licensed veterinarian. They will also come with a certificate of health from our veterinarian. All of our puppies and adults are on a very strict medical program including vaccinations, preventative shots, scheduled deworming, heartworm preventative, parasite control, vitamins, and a quality-high protein dog food.

### **PAYING FOR PUPPIES**

A deposit of \$300 down is required to hold your puppy. Deposits are non-refundable after puppies are 5 weeks old. Full payment is required at the time of pick-up. Price of the puppy includes: 8-week shots, deworming, registration, veterinarian check, and health certificate.

#### SELLER'S WARRANTY TO BUYER

Seller warrants that the above described puppy has been examined by a licensed veterinarian at 8 weeks old, and was found free of any health problems. In addition, if the

puppy is 8 weeks or older, the required shots and deworming have been done by said

veterinarian. Seller warrants that the puppy is free of any health problems.

This puppy is bred as a companion animal. Any statement regarding size is Breeder's

best estimate only.

Seller guarantees the puppy against any inheritable/genetic defects for a period of 12

months. Should a licensed veterinarian determine that such genetic defects are present

within a 12 month period, the buyer may return the puppy to the seller for a replacement

puppy out of the next available litter. Should the buyer decide to return the dog, the seller

has the right to have an independent veterinarian provide a second opinion on the

diagnosis. At no time is the seller responsible for any veterinary bills after the dog is

purchased.

**BUYERS WARRANTY TO SELL** 

Buyer agrees to have the puppy examined by their own veterinarian within 72 hours of

delivery of the puppy, and to inform the seller immediately of any health problems that

may be detected.

Buyer agrees to receive the puppy in person, as the seller will not use any means of

shipping to deliver the puppy.

Transportation of the puppy for delivery, or due to health problems is the responsibility and expense of the buyer.

Should the buyer decide for any reason that they cannot keep the puppy, the seller has

Should the buyer decide for any reason that they cannot keep the puppy, the seller has first right of refusal. Seller also agrees to help the buyer find a new home for the puppy through our web page and other contacts. Seller will not charge a commission or require any fee for this service.

Buyer agrees that under <u>NO CIRCUMSTANCES</u> will they ever place the puppy in an animal shelter or research facility.
